CLE Programming

For the first time in several years, at this year's Annual Meeting HIS presented an entire afternoon of timely and relevant CLE programming. Thanks to all that attended! If you were not able to make it, here's what you missed:

Immigration Upheaval in Texas - DACA, DAPA and the Unaccompanied Minor Crisis

Speakers: Frances Valdez, F. Valdez Law PC, Houston Edna Yang, American Gateways, Austin

Frances Valdez provided information on the ins and outs of submitting applications under the Deferred Action for Childhood Arrivals (DACA) and Deferred Action for Parents of Americans and Lawful Permanent Residents (DAPA) programs, including eligibility requirements and disqualifications. Frances also discussed pending lawsuits threatening the expansion and further application of these programs.

Edna Yang provided an update on the numbers of unaccompanied minors coming across the border and issues that have arisen as to detention of minors and families. Several HIS members have stepped up to take Special Immigrant Juvenile Status (SIJS) cases to help these minors obtain immigration relief and remain in the United States. There remains significant work to be done on this issue. Energy Law and Opportunities in Texas and Mexico

Speakers: Alex Gonzalez, ExxonMobil, Houston

Alfredo Ramos, Gardere Wynne Sewell LLP, Houston Alfredo Gutierrez, Sanchez Oil and Gas, Houston

Alfredo Ramos provided information on opportunities that have arisen in Mexico as a result of energy laws enacted in Mexico in 2014, including joint venture opportunities for midstream operators and infrastructure development. Alfredo Gutierrez gave an interesting presentation on of minimization of theft and fraud during a business boom cycle from the perspective of in-house counsel, including issues relating to internal theft. Alex Gonzalez provided a discussion about general and personal jurisdiction in toxic tort litigation.

The Callejo Legacy - A Retrospective of the Accomplishments of Adelfa and Bill Callejo

Elisabeth Wilson and Marcos Ronquillo shared historical perspective and personal anecdotes regarding Adelfa and Bill Callejo, two beloved members of the Hispanic legal community. The presenters discussed the Callejos innumerable accomplishments as civic, legal, educational and community leaders in the Dallas area and throughout Texas.

The CLE was followed by a joint reception co-hosted by HIS and the African-American Lawyers and Asian-Pacific Interest Sections, at which HIS gave out its annual awards.

Hispanic Issues Section OCTOBER 2015

HIS ANNUAL AWARDS —

HIS honors members of the Hispanic legal community at its annual meeting through a number of achievement awards. These recipients represent the best of our profession.

Bar/Organization of the Year: Dallas Hispanic Bar Association (DHBA)

DHBA's extraordinary year included outreach efforts in the Dallas/Fort Worth metroplex and the surrounding areas to community members, high school students, law students, and attorneys. In addition, DHBA distinguished itself in being one of the first bar associations in the country to address the unaccompanied minor crisis, and doing so in a concerted and systematic way that served as a model to many others, including the Hispanic Issues Section. DHBA created an Unaccompanied Minors Action Committee, coordinated efforts with Catholic Charities of Dallas, Inc. and the Human Rights Initiative to provide CLE's, to organize educational forums and to work with local immigration courts.

Judge of the Year: Justice Patricia Alvarez – 4th Court of Appeals

Justice Alvarez is a former Chair of HIS, former President of the Mexican American Bar Association of Texas, active member of ABOTA, Past State Bar Director of District 12, Chair of the Professional Development Program, Board Member of the State Bar College. She is the 2015 recipient of the State Bar College Professionalism Award, and is a true visionary and leader!

James W. Wray Jr. Founder's Award: Nina Perales - MALDEF

Nina Perales is a leading civil rights litigator and an expert on immigrant rights, voting rights and redistricting litigation. A graduate of Brown University and Columbia School of Law, she has successfully argued before the U.S. Supreme Court. HIS recognized Nina for her tremendous efforts and work over many years fighting for the rights of Latinos throughout the country.

Legislator of the Year: Congressman Filemon Vela (Brownsville)

Congressman Vela is the first representative from the newly created 34th Congressional District of Texas. A native of Brownsville and the son of Southern Federal District Judge Filemon Vela, he has fought for immigration reform on behalf of migrant workers, dreamers and undocumented minors. He was the first Congressman to file a comprehensive immigration reform bill in the House of Representatives and has led a discussion for rational, reasonable solutions to the country's immigration issues.

Pete Torres Public Service Award — Richard Loza, Project Director Texas Rio Grande Legal Aid (San Antonio) Bexar County Family Justice Center

In addition to his duties of litigating cases on behalf of survivors of domestic violence and abuse, Richard Loza trains volunteers with the San Antonio Police Departments' Family Assistance Crisis Team, volunteers with Catholic Charities San Antonio's Ask A Lawyer Program, co-chairs the San Antonio Bar Association's (SABA) People's Law School, assists with the SABA Mentor Program, assists with the Mentor Community Justice Project and for the second year was Awarded "Mentor of the Year" by the Hispanic Law Students at his alma mater St. Mary's School of Law. Richard truly exemplifies service and volunteerism in our profession.

Reynaldo Garza Lifetime Achievement Award — Gloria Leal

In the words of Justice Gina Benavides, Gloria Leal is a pioneer and a trail-blazer. Angelica Hernandez is a partner in the Houston firm of Linebarger Goggan Blair & Sampson. She was honored by the Houston Bar Association with its President's Award in 2014 and honored by her firm as Attorney of the Year in 2014 for her professional work and work in the community.
